I am writing to you as a member of the academy's community to share with you the plans for the school to change its age range from 3 – 7 years to 2 – 7 years. The school provision proposed, under the governance of Ryhope Infant School Academy, will be for 16 places for 2-year-olds, the places will be for children eligible for 15 hours of free early education or to parents/carers who wish to pay themselves for this.

The aim of our Early Years provision is to prepare children for school readiness and with the development of a 2-year-old nursery class within our existing nursery, this will provide a single transitional site for those families who wish for their children to progress through one education establishment.

We would like to hear the views of everyone associated with the Academy. This includes children, parents, local nurseries, childminders and other community partners.
